# **CV Summary**

My research specializes in intergroup relations, focusing on collective action, diversity, acculturation, collective narratives, conflict, social emotions, and cohesion through experimental and survey methods, providing evidence-based insights into intergroup dynamics across diverse domains.

**Scientific Achievements** 

My research has resulted in high-impact contributions, with a progressive increase of the profile of my publications. I have published in top-level journals in my area in Europe (e.g., *Group Processes & Intergroup Relations, European Journal of Social Psychology*) and globally (*Emotion, Political Psychology, Cultural Diversity and* 

*Ethnic Minority Psychology*). My productivity is reflected in almost 60 publications from the Web of Science Core Collection and 11 contributions to book chapters, with high citation impact (2157 citations on Google Scholar). My research has been recognized with an Extraordinary Dissertation Award from the University of the Basque Country and a Young Researchers Award from the Spanish Scientific Society of Social Psychology.

#### **Internationalization and Mobility**

My scientific trajectory covers in total 16 years at the Dept. of Interdisciplinary Social Science at **Utrecht University** (the Netherlands), the Dept. of Political and Social Sciences at **Pompeu Fabra University**, and the Dept. of Social Psychology at the **University of the Basque Country**, complemented with mobility periods at renowned institutions such as New School of Social Research (the US) or University of Kent (the UK). These experiences have fostered collaborations with distinguished researchers in emotions (e.g., J. Zickfeld, Denmark), acculturation and intergroup relations (M. Verkuyten, B. Martinovic, the Netherlands), and collective memory (J. Vollhardt, the US; M. Rupar, Czech Republic). I participated in the EU-funded IS1205 COST Action on collective memories (e.g., L. Licata, O. Klein, Belgium), and international large-scale projects such as World History Survey and Digital Influence Survey (J. Liu, New Zealand). In the framework of my EU-funded MSCA Fellowship, I have started creating an international, interdisciplinary research consortium in the field of study of non-verbal expression of emotions in intergroup relations (<u>tearaid.edu</u>). I have been a collaborator in an ERC-funded project <u>OWNERS</u>, implemented at Utrecht University.

#### Leadership and Funding

In 2020-2021, I led a **Marie Skłodowska Curie Individual Fellowship** at Utrecht University (European Commission,  $\in 175,572.48$ ; a proposal ranked among top 3.7% in its panel). Additional funding includes grants from "la Caixa" Foundation ( $\in 17,000$ ), Utrecht University ( $\in 9,996$ ), and European Association for Social Psychology ( $\in 24,000$ ) for organizing three scientific events: "The Role of Emotions in Interethnic Relations," Utrecht; "Understanding and Transforming Challenging Relationships: Setting a Research Agenda for a 21st Century Social Psychology," San Sebastián; and "Emotional Crying in Social Context," Lodz. As Ramón y Cajal and Ikerbasque Research Fellow, I secured  $\in 92,000$  in research funds. Recently, I obtained competitive funding from the Spanish Ministry of Science, Innovation and Universities for the project titled "HERMES: Healing Effects of Role Models for Empowerment and Solidarity" (PID2023-151315OA-I00, 166,625€).

#### Social Impact and Citizen Science

Along my career, I have prioritized **connecting academia and civil society**. In the framework of the <u>SOS Racismo</u> <u>Gipuzkoa</u> university section at UPV/EHU, I coordinated the European Commission-funded project "Voice 4 **Migrants**" (€137,500) and two local research projects ("Refugees: Reflection and Perception" and "The situation of foreign domestic workers in Gipuzkoa") financed by Gipuzkoa Provincial Council and Basque Government (€14,380), as well as assessed the impact of social mentoring and democratic culture oriented interventions (€5,882 + €14,999). I am currently engaged in research projects and contracts in synergy with SOS Racismo focused on rights advocacy and the political empowerment of migrant women workers, including "Dignified Work, Dignified Care" (Kutxa Fundazioa, €72,400) and "Zabaltzen: Political Empowerment Academy" (Basque Agency for Cooperation, €11,570.24). In the framework of MSCA fellowship and the current HERMES project, I collaborate with non-governmental organizations such as <u>Refugee Today</u>, <u>Moviltik</u> or <u>Good People</u>.

#### **Mentoring and Community Service**
